Sub.: Re-organisation of existing Central Excise, Service Tax, Audit and Appeals Commissionerates of Visakhapatnam Zone.

The taxpayers/trade are hereby informed that the Government of India vide Notification No.13/2017-Central Excise (N.T), dated. 9th June, 2017, has notified the territorial jurisdiction of the respective Central Excise, Service Tax, Audit and Appeal Commissionerates of this zone.

2. Consequent upon the above said Notification, the Visakhapatnam Zone will be headed by the Chief Commissioner of Central Excise, Service Tax and Customs, Visakhapatnam and will comprise the following Commissionerates:


3. The jurisdiction of the Commissionerates, Sub-Commissionerates, Divisions and Ranges of the respective Commissionerate viz. Visakhapatnam Commissionerate, Guntur Commissionerate, Tirupati Commissionerate, Guntur Appeals Commissionerate and Circles of Guntur Audit Commissionerates are as per Annexure - I to Annexure - V.

4. The jurisdictions of the Commissionerates take into consideration the present jurisdiction of the Districts of State of Andhra Pradesh (Kurnool, Chittoor, YSR Kadapa, Anantapur, East Godavari, West Godavari, Krishna, Guntur, Prakasam, Sri Potti Sri Ramulu Nellore, Visakhapatnam, Vizianagaram, Srikakulam). These jurisdictions will not undergo any change if the jurisdiction of the Districts, Wards etc., undergo any change, until the same is notified by the competent authority of this Department.

5. This Trade Notice will come into effect from the date the Notification No. 13/2017-Central Excise (N.T) dated 09.06.2017 becomes effective, as will be notified by the Central Government.

6. The tax payers / trade are requested to carefully note the change in the jurisdiction of the Commissionerates / Divisions / Ranges / Circles. All the members of the Regional Advisory Committee and Trade Associations, Chambers of Commerce in the State of Andhra Pradesh are requested to circulate this Trade Notice among their constituent members for information and guidance.
